Judie,

Though I acknowledge it is less than clear, it is my opinion that projects that are totally funded by the Commission's budgeted funds (or which is totally funded by grants, donations or other sources), may be contracted for by the Commission without following the notice, hearing and other procedural provisions of Section 7. But if any of the cost share is to be passed through to a member, the procedural protections provided by Section 7 must be followed.

In short, my conclusion is based in part on how Chapter 429 and 103B work in conjunction—both authorize projects, and that authorization is separate and distinct from the improvement and assessment procedures that must be followed when the project is to be funded with special assessments. Please contact me if you need more analysis or want me to lay out my reasoning.
